Catalog Description

Students analyze the theatrical experience for the audience with an examination of theatre's relation to the broad contemporary scene as well as its relations to past eras. In addition, students examine the production elements necessary to provide the theatrical experience.

Course Description


This course will introduce students to the theatrical experience. Students will develop a basic understanding of theatre as a living and viable artistic medium. Throughout the course, students will examine theatrical production practices (contemporary and historical), role of the audience, and the theatrical experience in relation to the broad contemporary scene. Teaching strategies include, but are not limited to, large and small group discussion, lecture, guest speakers, audio/visual materials, practical applications of ideas, and group presentations.

Course Goals & Learning Outcomes

Upon successful completion of this course students will be able to...

- Synthesize and interpret artistic expression of theatre artists, and their work on plays
 and musicals, in different periods of history in order to communicate from a critical and
 informed perspective.
- **Analyze** creative works, be they written, performance or rendering, and other works of the human imagination.
- **Discuss** and **interpret** theatre as a means of social change and commentary.
- **Evaluate** the interplay within the theatre production team as a conceptual and collaborative process.



Required Materials: Some required reading will be posted in Blackboard and/or a link will be provided to the source. At times instead of required readings you will be asked to locate the information on your own, in those instances a reading list will be provided. The main text for our class is *The Enjoyment of Theatre*, 9th edition, by Jim Patterson and Tim Donahue. You need to have a copy of the text by the beginning of Week 4.

Assignments:

You will receive detailed instructions for assignments and exams throughout the semester in class and on Blackboard.

Syllabus Quiz: The syllabus is our course contract, and you are responsible for the information in the syllabus, worth 25 points. See course calendar for due date

Library Quiz: We will have an embedded librarian for our course and the librarian will also spend class time with us going over the resources at our library. After reviewing the materials and discussions, you must complete the library quiz, worth 25 points. See course calendar for due date.

Participation: Participation is a large part of this course. We talk about theatre and we do theatre! As to the fluid nature of the course, participation assignments/points may take the following forms: in classexercises, in-class workshops, online discussion board posts, pop quizzes (in-person), quizzes (online only), reflection statements (due online or in person), bring objects/materials to class for in-class activities, warmups, scene work, choreography, peer review, etc. These all will be announced in class and sometimes online. A Blackboard announcement and/or post in our Participation folder on Blackboard will be provided after the announcement in class. Participation assignments will not appear on the course calendar. 400 points total (over the course of the semester).

Playwrights for Social Change: Guidelines will be provided in class and posted on Blackboard. See course calendar for dates, worth 100 points total.

Play Response: You will attend one play or musical production at SHSU in the department of theatre and musical theatre. Specific guidelines will be provided in class and posted on Blackboard. See course calendar for specific production dates and assignment due date, worth 100 points total.

Design Project: The design project is a group project. Specific assignment guidelines will be provided in class and posted on Blackboard. See course calendar for assignment due dates, worth150 points.

Exams: There will be two exams: one at mid-term and one at the end of the semester. Each exam is worth 100 points. The exams will take place online and you will have a set number of days to complete them (see course calendar). Further explanation will be provided closer to the time of the exam.

Writing Style Requirements:

Please follow MLA formatting for all written work. (Don't worry, I have examples and websites to help you). All written work is to be typed (size 12, Times New Roman font, double-spaced, with 1" margins), carefully proofed, and free of grammatical, spelling, and formatting errors. Pages should be numbered, and your name, the professor's name, the class name, and the date should appear on the first page. (Review MLA guidelines for proper headings - don't worry, I'm here to help you with this.)

CLASSROOM POLICIES

Attendance Policy: Students are expected to regularly (and punctually) attend scheduled class meetings. A tardy past 5 minutes is an absence for the day. This is a face-to-face course. There is no remote option. If university operations change due to Covid, I will update the policy and post it under our START HERE section on Blackboard. You will not be penalized for up to 3 absences, nor for any absence due to pre-approved religious observance and Covid related illness. After 3 absences, 5 points will be deducted from your participation grade for each excess absence. Also, 3 late arrivals = 1 absence. You must always take full responsibility for classes missed. Students who have been diagnosed with COVID-19, have been in contact with any person who has been diagnosed with COVID-19, or are experiencing COVID-19 symptoms, or any illness: PLEASE DO NOT COME TO CLASS. Remember DUE date does not mean DO date. DO - a verb, to perform an action, such as working on an assignment. DUE – an adjective, the time/date when something must be completed. You want to go ahead and DO it before it is DUE.

Engage in classroom discussions, ask questions, draw from your own experiences; make the connections between your own experiences and the course material.

A part of my role as a professor is to give you the tools with which to actively pursue your education. I will not do the thinking for you, but I will help you to find your best way of learning. The arts community is an ever-changing society constantly reinventing itself. I will encourage you to continually question and reexamine your place in society as you and society changes. In this way, we can become learned citizens who can critically and reflexively engage in the world around us.

- I will provide weekly communication with the class through announcements (in class and on Blackboard) and email notifications.
- I will provide email responses within 24-hours of receipt during the hours of 9:00AM-4:00PM, Monday-Friday.
- I will provide grades and feedback (as needed) to assignments and projects within two weeks of the submission date. If something prevents me from this, I will communicate the adjusted timeline.
- I will provide feedback to discussion boards/participation assignments/worksheets as needed in a timely manner.
- I will provide clear and concise instructions on how to complete the course requirements.
- I will provide a range of opportunities to engage in the course content in a meaningful way.

Student Responsibilities

I care more about the people my students become than the grades they earn in my class. If you are focused on scoring that A, you will miss the experience. Don't worry about what I'm thinking, don't worry about disappointing me – I want to see you putting in the effort and engaging the material.
